### Terms and Condition on Rental Agreement

- **Terms and Conditions**
  1. The definitions and rules of interpretation in this clause apply in these terms and conditions.
  2. Headings in these conditions shall not affect their interpretation.
- **Agreement between Scribe and the Customer**
  1. Under the Conditions, **SCRIBE** agrees to supply the Customer with the Printers, the Services and the Supplies.
  2. The Customer agrees to accept at least one Printer under the Conditions and to purchase and accept the Supplies, and pay the Price to **SCRIBE**.
- **Commencement and Durations**
  1. The Contract shall start on the date when the Customer signs the order for the Printers and Supplies to be supplied to the Customer under the Contract.
  2. The Contract shall continue in a whole date of agreement signed by the Customer or until it terminated by **SCRIBE**.
- **Obligation of the Customer**
  1. The Customer shall accept the Printers and acknowledges that he/she obtains no title to the Printers under the Contract or otherwise. The Customer may not dispose of, part with possession or control of, lend, sell or give away the Printers, or create any lien or encumbrance over, or otherwise deal with, the Printers.
  2. The Customer may not relocate the Printers to other premises other than those to which they were supplied, without the prior written consent of **SCRIBE**.
  3. The Customer shall protect the title which **SCRIBE** has to the Printers and shall keep the Printers free from distress, execution or other legal process.
  4. The Customer shall purchase all their requirements for the Supplies for the Printers **SCRIBE**, and the Customer may not purchase from, or install in the Printers, Supplies from any other supplier. The consumption of Supplies by the Customer must substantially comply with the estimate given by them in the usage form completed by them in order to obtain a Printer from **SCRIBE**.
  5. The Customer shall allow access to the Printers for the staff of **SCRIBE** during the hours of 10am up to 5pm, Monday to Friday inclusive.
  6. The Customer shall locate the Printers in positions suitable for the proper operation of computer printers, and shall not cause or permit damage to them nor allow any person to do so. The Customer shall pay **SCRIBE** in full for any damage or loss occurring to the Printers.
  7. Physical damage made by the Customer will not allow to repair or fix by **SCRIBE**.
- **Obligation of SCRIBE**
  1. **SCRIBE** shall supply to the Customer the Printers with payment for the supply of product by the Customer, and **SCRIBE** shall retain title to the Printers at all times.
  2. **SCRIBE** shall supply to the Customer the Supplies and the Services for which the Customer shall pay **SCRIBE** the Price contained in the then current price list of **SCRIBE** consumables which prices shall be up to 40% cheaper than the equivalent OEM product.

3. The Printers, Supplies and Services shall be provided by **SCRIBE** to the Customer as soon as possible after the date in agreement issued.
4. **SCRIBE** provided on technical services if the printer has troubleshoot or repair request

• **Price and Payment**

1. The Price shall be paid by the Customer to U Print Ltd without deduction or set-off.
2. The Price will usually be expressed as not including VAT, which **Scribe** shall add to its invoices at the appropriate rate.
3. The Customer shall pay invoice submitted to it by the **SCRIBE** in full payment by the day was sent by **SCRIBE** as the Customer requested it

• **Liability and Loyalty**

1. In this portion you'll only purchase products on **SCRIBE** as the agreement or end of the contract
2. Any action or purchasing to other supplier, **SCRIBE** will automatically terminate the contract and pull-out the printer.
3. Continuing purchased the **SCRIBE** products will also continuing it's services upon signed agreement.

• **Termination**

1. Termination will only apply when you fail to continue subscription on **SCRIBE** products or end of contract.
2. Also applicable when **SCRIBE** notice that you subscribing or purchasing products on other dealer or supplier.
